Sealed Bids with necessary supporting documents must be submitted to the office of the Malarani Rural Municipality, Office of the Rural Municipal Executive, Arghakhanchi, Nepal on or before 12:00 on 2075/06/15 (oct.01, 2018) ie 31th day from the date of first notice published. Documents received after this deadline shall not be accepted.
- 3. Bids shall be opened in the presence of Bidders' representatives who choose to attend at 14:00 on 2075/06/15 (oct.01, 2018) ie 31th day from the date of publication at the office of Malarani Rural Municipality, Office of the Rural Municipal Executive, Arghakhanchi, Nepal.

Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security minimum amounting as in the given table or in the form of unconditional Bank guarantee from A class Bank in favor of Malarani Rural Municipality, Office of the Rural Municipal Executive, Arghakhanchi, Nepal which shall be valid for minimum 30days beyond the bid validity period.
