Invitation for Bids for the Construction of Chief Administrative Building

- 1. The Government of Nepal [GoN] has allocated funds from GoN towards the cost of Construction of Chief Administrative Building and intends to apply part of the funds to cover eligible payments under the Contract for construction of chief administrative building (NCB/MRM/B/06/77/78). Bidding is open to all eligible as per Section V of bidding document..
- 2. *Malarani Rural Municipality* invites electronic bids from eligible bidders for the construction of *Chief Administrative Building* under National Competitive Bidding Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 5 years: NRs. 6,35,00,000
- Minimum Work experience of similar size and nature: <u>1 building within 5 years with a value of at least</u> 2,00,00,000.
- 3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

- 7. Electronic bids must be submittedthrough PPMO's e-GP system www.bolpatra.gov.np/egpbefore 12:00 PM on 15 Oct. 2020.
- 8. The bidswill be opened in the presence of Bidders' representatives who choose to attend at <u>15 Oct. 2020, 1:00 AM</u> at the office of <u>Malarani Rural Municipality, Khanadaha, Arghakhachi</u>. Bids must be valid for a <u>period 90 days</u> after bid opening and must be accompanied by scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum <u>of</u> NRs. 8,00,000, which shall be valid for 30 days beyond the validity period of the bid (i.e15th Jan 2021)
- 9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
